

#### TREES IN THE SUMMER

Please do not trim the Oak Trees during the summer. This must be completed during dormant (winter) months. If you must cut, please consult a certified arborist and if you have storm damaged trees, please address them ASAP (within 24 hours recommended) and seal ALL wounds with an appropriate latex tree product.

#### SPRING TIME PERIMETER WALK

The Annual greenbelt perimeter walk took place May 20th. Board representatives assessed the entire border of the common property known as the greenbelt where it abuts resident's properties to make certain the common boundary is properly maintained. We noted a few encroachments and will be notifying those lot owners. For those residents who are fortunate to live on the greenbelt, you have a responsibility to make sure you do not encroach on the common property. Please check your property line to make sure you do not have any structures or landscaping, have not placed any brush, lawn clippings or leaves, or have not cut/mowed or trimmed any part of the greenbelt beyond the numbered 4x4 wooden posts marking the property boundary. # The History of Dunham Lake

FEATURE STORY

**PART ONE: BEFORE THE WHITE MAN** – By Carolyn Richards



Carolyn was a longtime resident of our area who had a great interest in the history of Dunham Lake and had researched and put together a series of articles which appeared in past issues. It's a good time to be shared again for new residents to enjoy!




Starting at the Beginning Once the Dunham Lake area was covered by thousands of feet of ice: the continental glacier of the last great ice age. As the climate warmed, the glacier melted and retreated northward. The melting edge passed this spot seven to twelve thousand years ago. It was then that our 110 acre lake was formed. A large block of ice broke away and was buried in the glacial debris that the melt water dumped here. When that block finally melted, it left a "kettle lake", irregular in size, shape, and slope, corresponding to the irregularities of the original block. The lake had three basins, the deepest being about 125 feet below the present water table, and a central submerged mound which rises to within a few feet of the present level

of the lake. There is no deeper lake

in Oakland or Livingston counties.

The hills of sand, clay, and gravel and the rocks throughout our subdivision are also debris left by the glacier's melting edge.



#### **Following the Trails**


Some Indians followed the mastodons and mammoths that wandered north with the glacier, and some remained over the thousands of years to hunt deer, elk, bear, raccoon, or opossum with spear and atlatl to fish turtle and snail from our lake and eventually to begin to farm corn and squash.

#### FEATURE STORY

By the time Cadillac built Fort Pontchartrain in 1701, there were two tribes that roamed our area, each having separate social structures and customs: The Saginaw Chippewa and the Pottawatomi.

Trails had first been used by animals filing through the forest, carving paths for the Indians to follow. The Indian trails became major arteries of commerce as they carried furs to the French Voyageurs in Detroit and returned to their villages with trade goods. These trails were narrow, worn by moccasin to a foot in depth in some spots. The Shiawasee Trail came very near the east side of Dunham Lake. It began at Detroit, branched north at Hannibel Tavern (Botsford Inn), and traveled northwest to Byron and Shiawasseetown.

In 1807, the Indians ceded away their claim to almost all of southeast Michigan, except for a few areas reserved for their use. They then used the trails to get to Detroit annually to collect their annuities of 50 cents a head from the British at times, but mostly the Americans. Later, the trails were used by government troops to herd the Pottawatomi to Kansas or to Canada, or even to the south shore of Orchard Lake. Many of the Chippewa died of the smallpox epidemic in 1837 or just remained in the white man's world. By the 1830's, most of the Indians had been fragmented and dispersed. But they had a trail for us to follow.



our southeast. A large Chippewa encampment existed each summer until 1915 at Dunham and Clark roads near Hartland, some individuals returning

until the 1920's to sell baskets.

After the land had been relinquished by the Indians, and before any white man could legally settle in Michigan, the land had to be surveyed by federa surveyors. The tremendous task of literally walking over the entire surface of Michigan and marking township and sections corners at half mile intervals began in earnest in 1815. Then Lewis Cass, who became the governor of the Territory of Michigan after the War of 1812, ventured out beyond Detroit to see the beautiful and fertile land of Oakland county, dispelling the previous notion that Michigan was the "home of every species of malarial disease, a land of irreclaimable and swamps and sand hills."

They put government marks near trees and rocks and described those locations in their field notes. In June, they suffered much from the mosquitoes, "both men and horses weak from loss of blood and want of rest." The surveyed lands could then be purchased at the U.S. land offices in Detroit, which opened in 1818.

We are so lucky to have such an extensive and beautiful path system around this lake. There are many times when I am out walking on certain portions of the path that I actually do think about the Indians probably having walked here in the past. And I enjoy how each side of the lake has a different look and feel to it.

#### Surveying the territory

#### THE BIRTH OF OUR KETTLE LAKE

# FROM ICE LAND TO WONDERLAND THE FORMATION OF DUNHAM LAKE


Dunham Lake was born from ice approximately 14,500 years ago during the last ice age that covered our area with up to a mile of ice. It was termed the Late Pleistocene (Wisconsin Glacial Period).

15,000 years may seem like a long time but in geologic time it is a relatively short period. To get this in perspective use your imagination to visualize 180 people in a room. Adding consecutive lifespans of 80 years for each of these 180 individuals would take you back around 14,500 years to that mile of ice covering our landscape — a not so distant past.

Now to try and grasp how thick this glacial ice pack was. Think of the majestic 120 foot height of the flag pole at our local La Fontaine car dealership and then take it straight up another 44 times higher, Or you might think of the distance between Hickory Ridge and Tipsico Lake roads straight up in the sky! That was a load of ice that makes today's worst winters seem balmy by comparison.

Locally, the glacial ice slowly melted opening on a diagonal from Brighton in Livingston County on to South Lyon in Oakland County and proceeding northeast to Rochester to expose our newly formed ground plain. One lobe of the glacier retreated northwest to the Saginaw Bay forming Dunham Lake and the other south and east to ultimately form Lake Huron and Lake Erie. Hence the region is know in geologic terms as an interlobate zone (between glacial lobes).

As the glacier melted back, large irregular blocks of ice occasionally broke free from the retreating glacial edge and settled into the melt deposited sand and gravel (till) carried to our area by the glacier from as far away as the Canadian Shield. The ice blocks depressed the landscaped and once melted formed Dunham Lake. Dunham Lake along with the multitude of lakes in Livingston and Oakland Counties are called kettle lakes.




The steep embankments on the north, east, and west lake margins are evidence of the till deposits up to the ice block wall, like a kettle. On the south melt-water formed an out wash plain with multiple drainage paths ultimately coalescing into today's Ore Creek, a tributary of the Shiawasse River which empty's into the Saginaw Bay.

Dunham Lake along th the multitude of lakes in Livingston and Oakland Counties are called kettle lakes. environmental diversity that evolved in our area such as the formation of a special wetland feature called a Prairie Fens supported by calcium rich hydrology. The Shiawasse River basin is particularly rich with these relatively rare ecosystems. Dunham Lake has its own just south of the water weir footbridge.

Our lake and region have a special story to tell of their uniqueness. So the next time you are on the south end trail, look north over the lake and try to imagine that mile high glacier rising far above the north horizon while retreating to the Saginaw Bay some 14,500 years ago.

# How does a kettle lake form?

A kettle lake is formed when blocks of ice left behind from a glacier bury into the outwash. Eventually the ice blocks will melt leaving behind a depression in the ground.

#### WEDNESDAY, FEBRUARY 7, 2018 Meeting called to order 7:34 pm

Others present: Pam Moran and John Griswold.

President's Report: Scott Oswald -

- He will distribute the contact list of the board members soon. Board meetings will be the 2nd Wednesday of every month at 7:30 pm.
- Carol VanSpybrook is creating a separate e-group of the board members. She has issued invitations to everyone on the board. Some people have had issues joining, because it wouldn't accept their email.

Vice President's Report: Fred Everhart -He should have more information about the resident survey at the March meeting.

Secretary's Report: Carla Gorton – Read minutes from last meeting. The minutes were amended. Kate made a motion to accept the amended minutes and Kristina seconded her motion.

Treasurer's Report: Jane Debbrecht -No report, as she is out of town. Cinda will reimburse some of the board members for Dunham expenses.

Civic Committee Report: They have an open position. Jane Debbrecht was appointed to stay on the committee for another term.

Security Report: Notices have been put at the gates about the plans to start locking them. Scott also sent out an email about it. He received both positive and negative feedback. Ed and Scott are going to be working on getting that project implemented. The new hangtags will be distributed this spring. The board will be ordering them in 2 year intervals to maintain the stock.

Infrastructure Update: News from Carol VanSpybrook – They are working on putting some posts in. Tom will check on the Porta Johns and the dumpster. Scott is going to check with a diver that he knows to see how deep the swim dock anchors are, as someone thought that the East Beach ones are too shallow and not safe.

Activities Update: Kristina is going to show Carla how to sign up kids for the summer beach clean-up.

#### Natural Resources:

- Megan is going to try to meet with John about the invasive plan. Does Fred want to be at the meeting too? How much money do we really want to invest trying to keep the invasive species out of the greenbelt? Will it do any good?
- Three people volunteered to be on the Oak Wilt Observation Team. They will watch for Oak Wilt on the greenbelt and in the neighborhood and report back to the board.
- There is still at least one day of professional tree cutting left to be done. Scott will contact them to do it before March, as it is safer to trim the trees in the winter. Cinda talked to the Fish Study person. The whole study will cost \$6,000. We will vote on whether to go ahead with the study at the March meeting. If we decide to do the study, then Ed will help Cinda with it. John said that he would start doing the study at ice out if it is O.K.'d.

Communications: Pam Moran presented what she has so far for the next Laker. It should be complete soon. Pam has also been working with a local printer to create a mail merge for the addresses of the residents. Gary is going to check with some printers that he knows too. Gary is going to talk to Jane Debbrecht about updating the webpage.

#### Old Business:

• Cinda ordered the 3 signs for the beach and parking lot and also the "No Trespassing" signs for the walk-in areas.

• The boats that were still left at the lake after Boats Out were taken to the park in January and tied up. Since then, they have all been claimed by residents.

#### **New Business:**

- There is a path on the west side that comes out to Dunham Road. It has logs across the path for water issues. It has been proposed that we put a boardwalk there to make it safer to use. It was decided that we are not going to address the boardwalk at this time.
- Kristina suggested that it would be easier if residents fill out a formal form when they are requesting action from the board. She created a sample form to show members. The board will refine it and then it will be put on the website.
- There seems to be more boats than ever at the lake. May need to address that issue more at future meetings.


