It is our goal to best serve the interest of our neighbors, and with this information we are able to check that our actions are aligned with resident feedback. As for the Board's effort, Kristina hosted a craft event this February and a few neighbors attended, or stopped by to say hello. #### THE PRESIDENT'S REPORT (CONTINUED)



Kate, Jen and Gary have continued to work on the website development and options for a replacement e-group, as Yahoo support is declining and it's time for an update. Keep an eye out for the notifications as we look to make this transition. We will look to make another option available for informational notifications from DLPOA only, as well as maintaining a two-way message board for residents.

Fred and Wes have handled some winter storm damaged trees on the greenbelt and are working hard to make sure the walking paths stay clear and free from overhead dangers. The tree crew will be back out this spring to address a few more trees and to remove a few challenging Norway Maples on the west side.

Tom cleared the concrete slab where the old neighborhood development office once stood. It offers a great view of the lake from atop the hill at the Main Park. Thanks to all of the Board for their hard work.

At the annual meeting, I was asked to check out some concerns with Gypsy Moths on the Livingston side. I've checked in with Dunham Hills and the MSU Livingston County Extension and the reports are, that while 2017 and 2018 saw increased populations, 2019 is expected to decline. Dry early spring weather conditions were not conducive to the fungus that combats the Gypsy Moth caterpillars those years but we are back on target for a normal season

according to the MSU Extension from the 2018 and 2019 hatches since the fungus was active again last year. She reminded us that if you have an unusual case or concern to contact their office for advice. They did NOT recommend widespread spraying as the poison used is indiscriminate to other insects that are not as pesky as the Gypsy. They also reminded us that the Gypsy Moth caterpillars do NOT impact the Oak Wilt situation, and that normal healthy trees can withstand a few years of Gypsy Moth infestations. Watch for the brown masses of egg sacks on trees, woodpiles, under your soffits on your home, and remove/destroy them if possible.

The Civic Committee is continuing administrative efforts to re-establish the west side Dunham road walking path.

For those neighbors who store boats down on the lakeshore, I ask for your cooperation to keep the shoreline orderly and not overcrowded. We have not had to restrict boat tags yet or reduce the areas where boats can be stored or create designated boat/ vessel storage racks away from the water's edge, but if we do not care for our lakeshore, measures such as these may not be far off. PLEASE, if you do not use your boat or just once a season, do not store it on the shore, keep it at home. If you do store your boat, please make sure you attend to it regularly and dump the water after a storm event. We are all well aware of the risks brought by mosquitoes like the West Nile Virus. Small stands can be used to support kayaks and paddle boards off the ground to allow the vegetation to grow below minimizing erosion effects. Thank you for your cooperative effort.

I know we are all ready for summer at the Lake including my daughter who has already been asking to go swimming and fishing. Looking forward to seeing everyone down at the beaches.

#### PARK GATE LOCKS:

The Board decided to keep the walkthrough gates open for the winter (starting when boats were removed from the lake December 1st ) and re-secure them starting in May (around the workbee weekend). This decision was made so residents didn't have to fumble with keys and gloves during the winter. The walk-through gates locks will be re-activated the 2nd weekend of May, so be sure to bring your keys with you. While we realize it's a slight inconvenience for residents to carry their keys, this helped significantly with non-resident walk-in traffic reduction last year. Your vehicle gate key is the same key used for these locks.

Operation is simple, insert the key and turn, and then either push or pull the handle to swing the gate. There are no levers or knobs to turn. Please close the gate behind you until the rest of the closers are installed. We appreciate your cooperation. We also have Dunham Lake lanyards available! If you'd like one to hang your gate keys around your neck or make it easier to find in your pocket or car, contact Kristina Oswald for one or two!

#### HANG TAGS FOR PARKING AT THE BEACHES:

Reminder, rear view mirror hang tags were issued last spring for parking privileges at the three parks (West Beach, Main Park, and East Beach). Each lot owner has 2 hang tags (renters and leasees must see their lot owner to obtain this pass). Please make certain any vehicles you take to the parks have this hang tag visible. Cars parked outside the gates on the street are subject to ticketing and towing.



## THE EAGLES **HAVE LANDED!**

The bald eagles have landed at Dunham Lake. November 2018 brought very cold temperatures, causing the lake to almost freeze over. With that, the geese and ducks were concentrated in a small area by the park. This in turn attracted bald eagles like we have never seen before. On the East beach in a deciduous tree, a juvenile bald eagle was crying out, while towards the north end of the lake, out on the ice, two mature bald eagles were eating somethingmaybe one of the many geese? These three stuck around a good three to four weeks. It is interesting to note that only a few years ago, it was unheard of the see one; now, they are becoming a common site.

#### FUN FACTS ABOUT BALD EAGLES:

- Females are larger than males.
- They eat mainly fish, but will eat ducks, geese and small mammals.
- They get their white feathers and start breeding around 4-6 years.
- They can live up to 30 years or more in the wild.
- They mate for life and return to the same nest.
- The nest can reach up to 9 feet in diameter and weight 2,000 lbs.!!
- The female usually lays 2 eggs at the end of February.

### FOR FUN ACTIVITIES!


The Activities Committee has been brainstorming over the winter to come up with a full calendar of events for this summer!

## The History of Dunham Lake

**PART THREE: CONSERVATION BEGINS** – By Carolyn Richards



Our previous narrations of the history described the earliest days at the lake, through settlement in the 19th century up to the 20th century. This section will take you through the combining of properties, the establishment of the bird sanctuary, and the woods, especially on the east side.

#### Preserving Dunham Lake Began with a Nature Lover!

Between 1830 and 1860, our country experienced rapid growth, and many new states were admitted to the union. In this area, new families arrived, some left, the children intermarried and often inherited their parents' land. Highland Corners (now West Highland) had a general store, a blacksmith, a post office, and an assemblage of families. Hartland was a bustling town with three general stores, a hotel, harness shop, grist mill, and saloon, and carriage makers, cooper (barrel maker), and cobblers. The area farmers raised corn, wheat, buckwheat, oats, and horses, sheep, and hogs.

In 1865, Henry Wallace and his wife Hannah Bailey bought the Carey farm on Dunham Road. The house was near the present Dunham Hills golf course entrance. They had left Ireland during the potato famine. He had been a plumber In New York City, and developed consumption (TB) from all the underground work. His doctor told him to move out West and start farming. He moved west-to Michigan!

SPECIAL NOTE: It was brought to my attention, Carolyn Richards was the original author of the early historical parts, not Anne.



The Wallaces had four children: Sarah, Alexander, Hannah, and Henry Milton. Henry Milton Wallace (known as H.M.), born in 1872, didn't like farming as a little boy. He hated the smell of the barn. But he loved to feed the chickens, ducks, and geese. He got his eighth grade education in the school down the road. He spent many hours reading under a tree. H.M. loved trees and planted the apple trees that today are along the driveway to the present clubhouse.

#### Henry Had Other Plans

His dad only believed in an eighth grade education, so after that, H.M. ran away and walked to Hartland High School in town. No doubt sensing defeat, his dad said, "If you're dead set on going to high school, you might as well use the horse in the barn." And so he did. He began Michigan Normal in Ypsilanti in 1891 and taught at his former grade school for two years. H.M. then attended the University of Michigan, and got his Bachelor of Law degree in 1896 and his masters in 1897. After a time in Alaska forming a gold mine corporation, he started a law practice in Grand Rapids, specializing in corporate law. He was a genius at setting up corporations. He also set up some oil and gas companies. In 1907 his mother died and H.M.

moved to Detroit to practice law. In 1908 his dad died. His sister Sarah had married and moved to Cohoctah, but Alexander and Hannah had stayed home to run the farm and care for their aging parents. When his parents died, H.M. wanted no part of the farm, rejecting his portion of the estate and accepting \$1 in payment.

Hannah married that year and moved to Milford. Alexander married the following year and continued to run the farm until he developed Bright's disease and was going blind. In 1915, H.M. traded the two rooming houses he owned in Ann Arbor for the farm. Alexander ran the houses, keeping boarders there.

#### What Started as a Hobby **Changed Everything!**

It was at this point that the very unique development of our subdivision began. Henry Milton Wallace owned the farm on Dunham Road and became a key figure in preserving our pure lake and enhancing beautiful setting for the future.

Henry Milton Wallace (H.M.) loved the Dunham Road farm where he was born and raised. He lived at the Plaza Hotel in downtown Detroit, but he became a gentleman farmer! He didn't own a car, so he hired a taxi to bring him out to his farm. He ran the

farm as a hobby. It was his recreation, a place to come on weekends and in the summer and a natural setting to bring his friends.

Being a corporate lawyer, he incorporated the farm that first year, 1915, as Lakeview Farms Company "for the conduction of general agricultural business." He formed General Supply Co. so he could buy fencing and equipment at unbelievable discounts. He formed the Lakeview Nursery so he could buy trees at low prices. He hired people to run the farm and improve the property. He got rid of the old equipment his brother Alex had held together with baling wire, and fixed up the house. He never did put a bathroom in it. That much modernization, he felt, would be sacrilegious!

#### Establishing a Wildlife Preserve

Over the next years he bought up as much of the land surrounding the lake as he could.

He raised chickens, peacocks, ducks and domestic geese, breeding areas, and planted an orchard.

H.M. took a special liking to one of his men, Jack, or P.L. Fordyce. Jack was faithful and honest, and H.M. made him the superintendent.

By 1921 H.M. had acquired all of the land surrounding the lake except for Hair's and the north end, Stewart's at the northeast corner, Belknap's at the northwest corner, Lee's 10 acre woods (Parkway Court) and a two acre subdivision, Eureka Heights, at the south end.

The very important process of the joining together of various parcels of land had begun, a process setting ours apart from other area lakes. Next, H.M. would change his Lakeview Farms Company into a wildlife preserve.

Between 1921 and 1925 however, all of these Lakeview Farms Company land parcels, plus the Belknap property were sold to the International Migratory Bird Preserve (I.M.B.P.), an Arizona corporation formed by Wallace. Shares were sold, but the corporation never made a profit. In fact it lost a lot of money. It was still Henry Wallace's hobby.

Why did Wallace change the ownership of his lands to this new corporation? First, the tax laws in Arizona were more favorable. Second,

if there were any legal disputes, they would be tried in a federal court, not a local one. H.M. believed he would have a fairer chance at the federal level.

Third, being a bird lover, H.M. had become a friend and admirer of the illustrious Canadian conservationist, Jack Miner. Miner was the founder of the bird sanctuary system in North America. He became the pioneer bander on this continent. He banded birds and kept a record of when and where the birds were shot and killed, thus securing authentic migratory information on seasons and routes. His lectures inspired many new sanctuaries to spring up, like the Kellogg Bird Sanctuary and the Mayo Bird Sanctuary and probably the I.M.B.P. here at our lake.

The State Conservation Commission had the power to establish state wildlife sanctuaries on privately owned lands when the owner filed for permission. And H.M. did. The original dedication as a state game refuge was in 1923 for five years and then again in 1927 for 50 years.

#### 40,000 Trees Planted Which Attracted Many Migratory Birds

This was a busy time at our lake. H.M. hired more people to care for his retreat. His superintendent, Jack Fordyce, brought his parents up from Indiana to stay in a house near the stream on what is now Murray Hill. This also became H.M.'s retreat house and a lot of effort went into improving that home.

Jack's brother, Russell, and his wife Rose also came. They lived in H.R.'s Dunham Road homestead. Jack and his wife Lena lived in a farm house on Dunham road near Fenton road, and for a time in the Belknap house at the northwest end of the lake where Briar Hill makes a sharp turn. Part of the chimney foundation of that house is still visible.

A German family, the Fultons, lived in a house at the southwest end of the lake near Konas' present property on Parkway.

Many of the old oaks were cleared out on the east side. There was a small sawmill there to cut the trees into boards. The lumber was stacked up



and used for docks and buildings. Over \$50,000 was spent on reforestation. The trees were purchased from Lakeview Nursery by the trainload and unloaded in Highland.

Between 1924 and 1927 more than 40,000 trees were planted on the high east side of Dunham Lake in Oakland county. Norway, Scotch, red and Austrian pines, arbor vitae, white fir, Norway, Douglas and blue spruce. Twenty to twenty-five acres of predominantly black walnuts (from seeds from China) were planted on the east side, alternated with Scotch and red pines. Several thousand other trees, all specimens, were planted in scattered high shore line and low drainage areas.

#### **DLPOA PROPERTY, PARK AND LAKE REGULATIONS**



The following regulations are designed to assure members and their guests the maximum benefits of the Association facilities. Strict observance of these rules is necessary for the accomplishment of this purpose. Any member violating any of these rules or engaging in conduct that is not in the best interest of the Association members will subject himself to such action as the Civic Committee and Property Owners Association deem advisable.

- 1 Park property (trees, brush, equipment, etc.) must not be destroyed or removed without the permission of the Property Owners Association and the Civic Committee. Violators will be subject to treble damages.
- 2 The use of water from Dunham Lake for private water systems is prohibited.
- 3 Members shall be personally liable for any damages to Association property resulting from careless, willful, or negligent acts by their families or their quests.
- 4 Glass containers are not allowed on beaches. All refuse in the park areas must be deposited in the trash containers supplied for that purpose. The dumpster is for park trash only.
- 5 Entrance gates to the Association Parks must be kept locked at all times.
- 6 Minors must have proper adult supervision when using Association property.
- 7 Parents shall be held responsible for minors actions when using Association property and facilities.
- 8 Boat docking on the beaches and swimming rafts is not permitted.
- 9 Picnics are not allowed on the swimming beaches.
- 10 There shall be no open fires for any purpose on the DLPOA common grounds, excluding approved charcoal and gas grills, with the exception of the following DLPOA Board sanctioned events where an approved container will be provided for use: Family Camp-out, Pig Roast and the Haunted Trail.
- 11 Overnight camping is not permitted in the park areas or on any subdivision lots.
- 12 All state fish and fire hazard laws are to be observed.
- 13 Boats must be identified with a DLPOA boat sticker to permit easy identification. All boats shall be completely removed from the water when not in use.

- 14 No private docks or rafts are permitted along DLPOA property.
- 15 No motors, gas or electric are allowed on Dunham Lake.
- 16 No motorized vehicles of any kind are allowed on lake or park areas, (mini-bikes, motorcycles, snowmobiles, or all terrain vehicles).
- 17 The use of firearms, air rifles, or weapons of any description is prohibited at all times in the subdivision and park areas.
- 18 No dogs are allowed on the beach areas due to sanitary and safety reasons. All dogs in the Main Park area must be restrained by a leash.
- 19 Swimming, picnicking, or congregating is not permitted after 10:00 pm.
- 20 No horses are allowed in the park or beach areas due to sanitary and safety reasons.
- 21 No guest will be admitted to the park and lake areas unless the lot owner host is physically present in the subdivision. Guests at the park who are 18 years or younger must be physically accompanied by their DLPOA resident host at all times while in the park.
- 22 The number of guests shall be limited to 10, except upon approval by Park Reservations of the Association.
- 23 All privately owned boats and apparatus associated with those boats must be removed from the park area by December 1st and are allowed back on the greenbelt April 1st.
- 24 Each property owner is limited to 2 parking places in the parking lots.
- 25 Smoking is prohibited on the beaches and all residents are required to properly dispose of cigarette butts.
- 26 If members and or quests violate any of these rules, they will be asked to vacate the DLPOA property.

#### TO MAKE PARK RESERVATIONS call Diane Blakeney at 248-408-7012

The DLPOA Board has set rules that are intended to allow Residents the use of the park for gatherings, but not to infringe on the rights of other residents using the parkland's. The DLPOA is asking each gathering sponsor to support the spirit of these rules and ensure their enforcement. In April 2017 the DLPOA Board approved a Park Reservation rate increase effective June 1, 2017. Rates will be raised to \$20 reservation and \$20 refundable deposit for parties of 10-30 people and \$40 reservation and \$40 refundable deposit for parties >30 people.

You can either retrieve your deposit or it will be shredded depending on whether or not the rules have been followed. The fees will go for the cleaning of the Porta-Johns and General Park cleaning.

#### Main Park Dumpster

The dumpster at main park is for park trash only, it is not intended for household use. Please use the meta can located next to dumpster for ashes from charcoa grilles. Do not empty hot coals into the dumpster.

## **DLPOA KEY POLICY**

- Only two keys will be issued per property owner.
- Replacement keys will be \$75.00 each.
- Property owner must sign for any keys issued to them.
- All dues must be paid prior to keys being issued.
- Property owner agrees to retain possession of issued keys.
- If there is a transfer of property, seller agrees to turn keys over to the buyer.

	8	Glass bottles are not allowed on beaches.
1	9	As the sponsor of the party, you are responsible for the behavior of your guests. If you require assistance, there may be park security on duty or you may call 911 for the police. Please be courteous and responsive to the security people. They are there to help and do their job to enforce rules.
g	10	Please contain the noise of your group: have fun but be aware of your neighbors who border the park area.
	11	Do not park on the surrounding streets near the park. You may receive a parking ticket.


Boat stowage on the Greenbelt is for RESIDENTS ONLY!

#### **Boat Regulations**

- By Michigan DNR statute, boats operated on Dunham Lake are to be NON-motorized. No motors, gas or electric, are allowed.
- Boat docking on the beaches and swimming rafts is not permitted.
- All boats stored on DLPOA lakeshore **must** have a **DLPOA identification sticker** to permit easy identification. (If your sticker cannot be seen when the boat is stowed, use a permanent marker to write your sticker number on a visible part of the boat or boat cover.) Contact Cinda Everhart at 248-889-4419 to obtain your sticker.
- All boats shall be **COMPLETELY** removed from the water when not in use.
- All privately owned boats and apparatus associated with those boats must be removed from the park area by December 1st and are allowed back on the greenbelt April 1st. Boats left on the lakeshore after December 1st will be relocated and restrained at the Main park at the expense of the owner.

#### **Boat Stowing Courtesies**

To all who store their boats down at the lakeshore — please be aware of the "**NO BOATS**" posted areas. There are 4x4 sign posts indicating where boats may **NOT** be kept due to ecologically sensitive areas. Boats found in



these areas may be relocated by the Board and restrained at the Main park at your expense.

- DO NOT place a tarp under the boat, as it kills off the natural vegetation.
- No part of stowed boat may be on the walking path.
- No part of stowed boats shall hang above the water line.
- If a boat is leaned against a tree, that tree shall be mature and strong enough to support the boat without damage to the tree.
- If a boat is leaned against a tree, the shortest side of the boat shall be upward.
- Water should be removed from each stowed boat on a weekly basis to minimize the breeding of mosquitoes.
- The choice of a location for boat stowage should, as much as possible, preserve the natural view of our beautiful lake.

We are so lucky to keep our boats on the Greenbelt, so please follow the rules of our lake!

Inventory levels continued to decline through January in most Southeast Michigan markets. Sales activity (showings and new pending properties) generally fell off in February compared to the prior month, yet closed sales were up 10%.

Heading into March, closed sales were remarkably even with last year (5,651 vs. 5,654). Values continue to rise, but at a slower rate than we've experienced over the past several years.

Closed volume has been up in all local markets except the Macomb County and Detroit Condo markets. Entry level markets continue to shrink (declining inventories and sales) while upper-end markets expand.

Developers have generally been focused on the luxury markets. As a result, upper-end markets are getting saturated with inventory. Although luxury sales were up last year, values showed signs of plateauing and even dropping in many areas.

While market conditions are generally shifting in a direction less favorable to sellers, the movement isn't necessarily favoring buyers either.

As prices, interest rates and property taxes continue to rise, many potential buyers are getting completely priced out while other buyers won't be able to afford the same home they could have purchased a year or two ago.

Although prices are increasing at a slower rate than they were, they continue to rise in most markets. Interest rates, which had a slight downward adjustment, are expected to continue to rise over the long term.
