ADDITIONAL IMPORTANT HAPPENINGS

Tree Nursing and Planting

This spring, the neighborhood obtained 158 tree seedlings from the Oakland Conservation District: 50 white pines, 57 white oaks, 21 red oaks, 9 serviceberry, and 21 red osier dogwoods. On May 15, over 20 volunteers helped plant them into 2 gallon nursery pots. This potting helped them grow another year taller and stronger in preparation for planting, increasing their chances of survival. Nine of your neighbors have adopted and cared for these seedlings as nursery families this summer making sure they stayed watered and healthy. They will be planted with focus on the areas on the west side greenbelt where the Norway maples canopy has been opened up enough for the sunlight to reach the forest floor and to support the infill with new native seedlings. Expert opinion varies on when they should be planted in the ground, whether this fall or the spring is the best time to plant them. Dates will be announced for volunteers to help set these into the ground. Notifications will go out via the e-group and website calendar. Target dates would be late October for the fall or March for the spring. For the seedlings that will overwinter in pots, they need to be set in the ground or mulched around to snuggle in for the season. I hope we can keep the wildlife from munching on these tasty little morsels over the winter. Adoptive families will be engaged to continue care for them this first year on the greenbelt, providing occasional watering and making sure competing weeds don't crowd them. This is a good chance for families with kids to adopt a tree and watch it grow up for the next generation. This tree planting is working in conjunction with the native grasses and wildflower planting for erosion control growth spread in 5 locations on the west side, north of west beach and areas around the BriarHill park stairs. We planted this seed where the undergrowth was sparse and there was enough



daylight penetrating the canopy to support growth. We will need to continue selective removal of Norway Maples to open the canopy, encourage under growth and restore life to the barren soil and eroded areas of the west side greenbelt.

Perimeter Walk

Did you know, our neighborhood greenbelt and common property is over 43 acres and includes a variety of different ecosystems? I'm not going to get into the science of all that in this note, rather I wanted to take a moment to remind those residents who have the good fortune of living adjacent to this wonderful space of the expectations and responsibilities for greenbelt border property owners. Please make sure you are familiar with the policies set forth by the Board that can be found on **http://** dunhamlake.com/association/rules-by-laws/. Know that in order to maintain that greenbelt border, an annual inspection and observation walk is performed to document the condition of the property boundary posts (the little 4x4 wooden posts with numbered tags) and to identify any private encroachments within the common property. We always welcome a couple residents to join board members on that spring walkabout. If you are interested to see the entire length of the common property, please consider joining us late April or early May, before the foliage is leafed out. For encroachments found, the suspected property owner is notified of the need for corrective action. Items commonly observed as violations of the greenbelt policy include:

- Branches or vegetation cut, grass mowed beyond the property boundary
- Leaves blown onto the greenbelt
- Items placed or mounted on the greenbelt including birdfeeders, woodpiles, dog run cables and flowers

These items will need to be removed and the greenbelt restored to its natural state for all to enjoy, just as if your neighbor crossed your own property line. We recognize occasional mistakes happen, lawn service companies, contractors, who unknowingly damage greenbelt property, please be sure they know the boundaries and it is your responsibility to report such mistakes to the DLPOA board. We will work with you to create a plan to restore any damage to the common property.

Thank you for respecting the boundary of the common area, for all our neighbors to enjoy. After all, it's ALL of ours to protect and maintain.

Beach Safety Improvements

Coming this Spring! You will notice new safety warning signage and posts with life buoys at each of the beach areas. After some near-miss incidents this summer, concerned residents brought ideas to the board for informative signage and options to have life saving equipment placed at the beach areas for emergency use. These will have high visibility, colored and labeled accordingly. If you have any questions, please reach out to a board member. Be safe out there!

Rafts Update

Have you noticed that the Board replaced the old wooden swim rafts this spring? With the great weather we've had this summer, these new rafts have been a big hit with the swimmers, young and old. They are aluminum construction, so they will be much easier to transport in and out of the lake each season during workbee events. They sit low to the water, so they are easier to climb on board. And, the surface seems to be cleaned without too much trouble. A special thank you to those families who helped maintain these rafts all summer. While they seem very well constructed and sturdy, PLEASE make sure your kids and their friends respect the rafts and the anchors, so everyone can continue to enjoy them for years to come. Please do not let the kids pile on one end intending to sink it, as this damages the structure of the raft over time and is dangerous for kids swimming on the opposite side. We are looking for ideas to keep the ducks off the rafts that won't be a safety hazard or easily vandalized—if you see a viable product, please let a board member know so we can check it out. Thank you everyone and hope you had a great time down at the lake this summer.

Other Notices & Thanks To All!

The Bulletin Board at the main park will be getting an update, look for construction to begin this fall.

We really do appreciate all the neighborhood families who help out with summer tasks like: locking the beach gates at night, the beach cleanup crews who raked the beaches every evening, families who helped keep the rafts clean for swimmers, tipping the boats to keep them mosquito free, and to those who helped pull and remove the invasive plants. With everyone's help, we removed over 50 bags of garlic mustard, asian bittersweet, and black swallowwort this summer. And thanks to those who served all that wonderful food and put on the games for the kids, and measuring and weighting fish for the Annual Pig Roast and Fishing Derby.

These tasks and more, will need to be supported again next year, and we can't do it without your involvement. We trust your family will consider signing up next spring to be part of what makes this such a great neighborhood.

Response to our most recent lake water quality and fish study

Water Quality Update

We are still actively working to identify the sources of water coming INTO Dunham Lake. If you know of any incoming sources to the lake that we may not have tested yet (see Water Quality Action Plan & Materials at www.dunhamlake.com. Go to Table of Contents then Lakes and Fish), or if you have any other helpful information, please contact Ed Cesa at cesa08@comcast.net.

Additionally, the Michigan Department of Environment, Great Lakes, and Energy (EGLE) hosted a presentation for DLPOA (and surrounding neighborhoods) to share where we are with the state. Conversations with our state contact, Barney, continue. Any work on the lake requires the State of Michigan's approval.



Boat Committee Update

Our first meeting was held August 8.

Members include: Jenny Vanderlist, Scott Oswald, Todd Bazzett, Tom Ham, John Schiltz, and Cinda Everhart.

We have begun to look at boats on the lakeshore and how we should handle these moving forward, such as: addressing issues; enforcement policies; other boat regulation topics.

Our goal is to further document expectations and obligations (policy and procedures) for the privilege to store watercraft on the greenbelt, with an anticipated publication date of Spring 2022.

SERVICES FOR HIRE

• Ed continues to take water samples from around the lake; we continue to see high phosphorus levels but are unsure why.

• Highland Township and Timber Lake Estates are examining Timber Lake's retention ponds to determine if they are working to the designed specs.

• Dr. David J. Jude, PhD., a Limnologist and Fishery Biologist, is a consultant and mediator between us and the state; we've offered to compensate him for his time. He proposed adding alum to the lake to manage the phosphorous content (which provides 15-20 years where phosphorus would be "locked up" containing the internal loading of the lake). The approach is costly. But, there are options for just treating the basins-estimated to cost about \$50k. We are waiting to be advised by the state on this.



THE HEALING NATURE OF DUNHAM LAKE

Walking the trails on Dunham Lake has always been refreshing. We did not know how refreshing it was until the pandemic hit. Even the worst days of COVID-19 were no match for the beauty and serenity of our lake. It appears we were not the only ones who thought this, since we saw many neighbors out taking advantage of the trails. As a bonus this year, a family of "Barred Owls" set up residence on the north Oakland side of the lake. Barred owls are large with a streaked chest, round, tuftless head and big black eves. While primarily nocturnal. they have also been known to call and hunt during the day.

Barred Owl Fun Facts:

- 1. They are very vocal and have a distinctive call sounding like: "Who cooks for you, who cooks for you all?"
- 2. They prefer nesting in tree hollows, but will use abandoned nests of squirrels, red-tailed hawks, and nest boxes.
- 3. They prefer to eat mice and voles, but sometimes go fishing for crayfish and if they eat enough crayfish, the feathers under the wings can turn pink just like flamingos.

Part of the beauty of this lake is due to the volunteers who work tirelessly keeping the green belt pristine. As we emerge from the pandemic, we appreciate the wonders of our lake even more.

EARLY SUBDIVISION ROADS **GOT IMPROVEMENTS**

In 1982, the Dunham Lake Association sought out a solution to continued road maintenance projects such as grading, excessive dust, and chloride treatments. At that time, they worked with the Livingston County Road Commission (LCRC) and the Road Commission For Oakland Co. (RCOC), using the Special Assessment District (SAD) Bill Program. By participating in this program, the roads were completed, financed and insured over a 10 year period. This decision benefited each person living on Dunham Lake, by increasing home values, cutting down on dust pollution and extending the life of our vehicles, for the last 39 years. As many of you have noticed, our roads are in disrepair and in need of some well overdue TLC. The degradation of the roads has been going on for some time now, and while others have attempted to go through the process for addressing the issues, we need time, patience, and persistence to see this project through to fruition.

BUILDING A CASE FOR ROAD REPAIRS TODAY

Last year Tom Waypa and Heather Kerr, decided to tackle the process again. They wanted to determine whether a majority of residents were interested in repaying our subdivision roads. They discovered several residents were interested, so they began the process.

STARTING THE THE PROCESS

The first step included gathering votes and petitions from residents. Each county's road commission works a little differently with financial guotes and initiating projects which impacts the process for votes and petitions.

Hartland Twp. prepared a financial quote upfront, and then required 70% of residents to agree to a special assessment quote by signing a binding petition. The binding petition includes a road assessment for up to 10 years or could be paid in full.

their next years' tax bill.

Currently Oakland County has 50% of residents interested in having a financial quote prepared. Now that Livingston County has achieved it's required 70% of signatures on a petition, we can all move forward to schedule a meeting with both road commissions. Our goal is to work in conjunction with each road commission to potentially retain the same road construction company, while also coming to a more plausible resolution to Murray Hill, as this road is split down the center between two separate townships and two separate counties. We will be setting up a date in September with Mike Luce, the public works director, who spoke at our road meeting, along with the RCOC, Mark Menzer and some residents from Livingston County.

TIPSICO LAKE EXCLUDED

Tipsico Lake Road residents have had several concerns throughout this process. The majority of the residents asked to be excluded from the project, at this time. Hartland Twp. agreed to have this portion of the sub excluded; for the remaining interior roads, only 70% of residents needed to provide signatures to have the project completed. So when the road project is completed, Tipsico Lake Road will not be repaved. Since Tipsico Lake Road has elected to be dropped from the previous financial quote, a new lesser quote was prepared. Unfortunately,

ROAD DISCUSSION UPDATE

Oakland RCOC requires a total of 50% of residents to agree they would like to receive a financial quote first. Names and addresses have been collected. This **unbinding contract** is a requirement for RCOC to send out an engineering team to prepare a financial estimate. When this quote is prepared, residents of Oakland County will be asked to formally sign a petition, agreeing to the prepared financial quote. This signed petition becomes binding for a road special assessment that would be attached to

Livingston County residents will need to resign a new petition to reflect the new quote at the meeting. This new quote wasn't substantial but did reduce the amount over the course of 10 years. We will be planning a meeting shortly, that will be announced, to have Livingston County residents re-sign the new petition at Dunham Hills Golf Course.

CORNER LOTS ADJACENT TO TIPSICO LAKE ROAD

Corner lots abutting Tipsico Lake road will only be assessed on one project (Either the first interior road project or when Tipsico Lake is paved in the future). This will depend on where the access point to enter the property is located. To ensure only one road assessment is placed on these particular lots, Hartland Twp. will be recording a document to ensure only one special assessment is placed on the property.

Several developments with this project have transpired and change often, so we will continue to post updates of the road project on the **Dunham Lake** Community Board on a weekly basis. If you haven't had the opportunity to join our community board through Google Groups I highly recommend it. It's a great way to get information about the community and stay connected.

Celebrating Dunham Lake with Neighbors

A CHAT WITH NEIGHBOR LARRY FALARDEAU - INTERVIEW BY PAM DEAR



If you attended the Dunham Lake Art in the Park and Happy Hour event in August, chances are you connected with Artist and Landscape Architect & Planner Larry Falardeau. Larry and his wife, Nancy, have lived in Dunham Lake for twenty-six years. I chatted with Larry at the main park earlier this summer to learn more about his life at the lake.

🔿 What drew you to live in the Dunham Lake community?

I grew up in this area and went to school in Milford. I had friends that lived out here, so I became aware of Dunham Lake and its beauty through word of mouth. These descriptions raised my curiosity.

This Place Leaves an Imprint What do you love most about living here?

Thank heavens for the visionaries who planned this development. The lake is a jewel—this size of a lake with such depth. It's exceptional that this community, the green belt, and the stewardship of the lake were made possible by political and private interests. People of diverse backgrounds and interests partnered to create a design and solution for a community around these amazing natural resources. A solution that Randall

G. Arendt (renowned author, lecturer, and landscape planner) highlighted in one of his books on conservation designs for communities.

I love the natural resources and the people's commitment to maintain them. I love that people are working together for a common goal to achieve and maintain the good of the community and the resources. To me, Dunham Lake and the greenbelt anchor me in time; some things shouldn't change. I'm thankful for the stewardship that supports these resources. It's a tribute to those that plan and maintain it.

This place is so special. I hear by word of mouth that children who were raised here return to live in the neighborhood later in life. Those that move away come back; this place leaves an imprint.

In what ways has the lake and community evolved over the time you've lived here? The greenbelt and the parks have stayed relatively the same—a tribute to those in our community that plan and maintain our common areas. According to the last lake assessment,

the lake is showing some degradation, but our board is on a mission to find out why. Is it the climate, septic use, land use, or a combination of items? We need to know before acting. If lake quality goes down, so does property value; they are connected.

The Outdoors Is in My DNA

How has your background affected your view of the lake?

My connection to the outdoors goes way back. My Dad grew up in Keweenaw in the Upper Peninsula. He and mom would go back every year. My first visit there I was still in my mom's womb, so the outdoors is in my DNA. When I was old enough to peek out the windows on these trips, I was fascinated by the views. There were no blockades back then to obstruct the view of the terrain across

the rivers. Once up there, my cousins, brother, sister, and I would head out for adventures. I was always curious, and these trips primed me to appreciate the beauty of the outdoors.

I became so fascinated that the terrain in Keweenaw was different than this area that I researched it. The area up north is volcanic and here it is sedimentary. (For a deeper dive into Dunham Lake's formation, see Larry's article From Iceland to Wonderland in the Summer 2018 issue of the Dunham Laker). And, did you know that Dunham Lake is the headwater of the Shiawassee River (not the Huron). I found that understanding Michigan's environmental story and being able to share that with others was a powerful asset. I was so overwhelmed by how unique the story was that I couldn't wait to share it with others.

I've never built barriers between my personal life interests and professional life, so my appreciation of the outdoors was integrated with my career. I earned a degree in Landscape Architecture and Design, and, for twelve years, I worked in private design offices. Then, I worked in the public sector for Oakland County as a Principal Planner. In these roles, I used my skills to tell the story of the interconnection of environment, aesthetics, and economics. I created visuals-my mind sees in pictures-to help tell the story. I shared the history of the land and how unique and special it is. If we understand how special the natural resources are, then we will want to care for the land and develop to ensure its integrity for future generations. For Oakland County, I initiated and facilitated the local stewardship of water, natural

areas, and trail system resources. I became known as the godfather of trails. Paint Creek Trail was developed under my facilitation, along with other trails. We linked water ways (rivers and lakes) and natural areas to the trails so that people could experience and live those connections. Helping people plan, collaborate, and connect to the outdoors was like opening a special gift. It was a rewarding time.

What drew you to live in the Dunham Lake community? Pat's sister lived here, and we loved the area. When her sister needed to

Dunham Lake is an Oasis What do you love most R about living here?

We appreciate the wildlife we see: coyotes, foxes, deer, raccoons, opossums, bald eagles, barred owls, tree frogs, hummingbirds, migrating ducks, ospreys, and loons. I love seeing and hearing the loons in the spring; it reminds me of up north. When we backpack we rarely see wildlife. In the wilderness, the animals avoid humans. Here they are stuck in the preserve, so we see them more often. It's a benefit for us.

Increased Appreciation

In what ways has the lake and community evolved over the time you've lived here?

There's increased appreciation of the greenbelt. And, greater awareness that what we have here is unique, and we must work to protect it.

The trail system is more developed now. Our first summer at Dunham Lake was very wet, and the trails were not well established on the Oakland side. The lower trail had no boardwalk; you couldn't walk through due to the fallen trees and mud. On the upper trail, it was difficult to discern where the greenbelt started and neighbors' yards ended. We were fortunate that a neighbor was a surveyor. She surveyed the plots, and then posts were added for a visual distinction for trail walkers and land owners. It's helped keep encroachment

to a minimum and trail walkers on the path, not in yards. Also there was no sand beach at the main park. That's where the boats were lowered. Sand was added in 1997 or 1998.

It was around 1998 when the Dunham Lake website was developed. Pat wrote the Patty Report for a couple of years. We shared what we saw around the lake-the good or bad, but with a positive focus. We often found trash on the beaches. Teen parties were an ongoing concern and liability, and we'd find the leftover beer cans at the beach. The more development that occurred in the area, the more pressure there was to crash the lake. Some adults outside of our community would even drop kids off in the afternoon and pick them up later. We've been through cycles of issues like this over time. (See Carolyn Richard's article A Timeline: Early Days from the Minutes in the Dunham Laker Spring/Summer 2021 issue). That's why gates and locks were put in place.

(Walt) In the early days, we didn't have a proven method for moving rafts for seasonal storage. Two neighbors used a paddle boat to move the raft from the teen beach to the main park. However, a strong south wind worked against them and

approach is used to this day.

Dunham Lake has always had community social activities like the pig roast. The board and community expanded the number of events with concerts, the haunted trail, the art fair, the triathlon and the red dress run/walk.

How has your packyround affected your relationship How has your background with nature?

We are both chemists. (Walt, a senior research associate with a doctorate, has 120 patents and Pat has 14 patents). Scientists are often stereotyped as not liking the outdoors, but that stereotype didn't fit us.

(Pat) Early on I wanted to be a park ranger. I researched the career path of a ranger and found that it didn't offer much financial stability, so I skipped that path. I always loved the outdoors, I did a lot of backpacking, and I wanted to live by a lake. (Walt) I had the love of the land instilled in me. My family was always in nature. We camped a lot, and I was also involved in the Boy Scouts.

The reason I got into science is because I was told I would never make

pushed them off to the point at the other end of the lake! I used a row boat with the help of a couple of lads to pull it back. Through desperation, we found we can walk the raft following the shallow areas of the lake and that

it to college—I had dyslexia. I made a decision to prove them wrong; it was a motivating factor. Also, partially due to my dyslexia, I sometimes preferred to be with nature rather than people.

A lot of what we do outdoors is because of Pat. She pushed my outdoor adventure horizons further: more wilderness and cross country activities. We biked across Michigan and canoed the Boundary Waters of Minnesota and Canada. And, we love SCUBA diving.

How has living at Dunham Lake benefited your life?

Dunham Lake was our escape from our professional work which was highly scientific and stressful. Given the option of relocation or early retirement, we chose the latter because we knew we would never find a place as nice as this.

President's Report: Fred Everhart -

- Fred & Cinda handed out the updated welcome packets to new residents.

- Scott acquired a quote for seed mix to plant on the west side. He emailed it to all board members for review. The quote is for a seed mixture that should work well in that area and should cover at least 2 acres. The board discussed it and approved purchasing half the seed, which will cover one acre.
- · Scott also figured out an estimated cost for seedlings that would be purchased from the Oakland Conservation District and the supplies that would be needed to put them in pots until they are bigger and able to be planted outside. 

Everyone is asking me about what has happened with the Real Estate Market...Well, here you go!

Last year's lockdowns, work-from-home and virtual schooling had people hyper-focused on finding more space and bigger homes. In the third and fourth guarter as markets reopened, extreme buyer demand set historic sales records that carried over into 2021.

With depleted listing inventory—less than half typical levels—buyers pounced on fresh listings as soon as they arrived. Multiple guick over-asking-price offers continued to set monthly historic records for both price and speed of sale. The second week of April, 64% of new pending sales had been on the market for less than ten days and the average market time for all pending sales was 17 days.

While sales and prices continue to rally, demand is mellowing. Inventory levels that had dropped 11 consecutive months began to rise in April. While the fresh listings provided needed fuel for the market and helped the sales run continue, many of the buyers that had been waiting to find a home have found it and are no longer looking.

Days on market, which sits at 17 days should rise. From March through early May, over 60% of new pending sales were on the market for ten days or less. That percentage has dropped to around 35%. In 2007, supply levels peaked at 19 months during the recession. At that point, inventory levels were 3x normal levels and demand was low.

In contrast, this past year's inventory levels are about half of normal while demand, bolstered by the pandemic, has been at an all-time high. That combination has dropped supply levels in half from 3.2 months (pre-pandemic) to 1.6 months.

Supply levels have bottomed and are back on the rise. The market with its out-of-balance supply and demand is easing toward balance. Therefore, look for seasonal trends to slowly return (including a burst of fall sales activity) for supply levels, market pace and prices as the market normalizes.


